### Updated Member Handbooks Available

As you know, safety has been, and always will be, the Isabella County Sportsman's Club's number one priority. To that end, we are always working to make the facility safer for all members, guests, and visitors. In the past year, we have made numerous safety improvements that include adding a closed circuit security system, moving the handgun range berm from 50 yards to 25 yards, adding an extension on the top of the handgun shooting area, and raising the handgun range berm to help ensure that shots cannot get over the top of the berm. We have also removed some in-ground target holders, changed the height of the target frames, and revised some of the rules regarding kneeling/prone shooting. All of these changes/additions have created a much safer environment for the members of the club and our neighbors.
