# Project Appleseed coming March 19 & 20

The Isabella County Sportsman's Club has the opportunity to host a program know as Project Appleseed later this month.

Project Appleseed is an apolitical marksmanship program that focuses on traditional rifle marksmanship from standing, sitting/kneeling, and prone positions. It is one of the major activities of the Revolutionary War Veterans Association(RWVA). The RWVA is a non-profit organization that teaches and promotes traditional rifle marksmanship while also

teaching American heritage and history with the intent of encouraging people to become active civically.

The two day weekend shooting clinic is termed "An Appleseed" from Johnny Appleseed, the American folk hero who toured the country, planting appleseeds so that future generations would benefit. Project Appleseed is designed to ensure the next generations will the benefit of the same Liberties as the generations before them.

There are two parts to the fee structure for this event. One part of the fee goes to

the host club. In our case that range fee will be \$10.00 for all participants. It will be collected at the gate on the first morning of the event. The other part is the fee that RWVA charges for the two day session. That fee is \$60.00 for adults and \$20.00 for those under the age of 18. They also let all active duty military, law enforcement officers, and disabled veterans participate for free.
